Prof. dr. Vito Bobek deluje kot profesor mednarodnega managementa na Univerzi za uporabne znanosti FH Joanneum (Gradec, Avstrija), na Fakulteti za družbene vede Univerze v Ljubljani in na Ekonomsko-poslovni fakulteti Univerze v Mariboru, kjer poučuje predmete s področja mednarodne ekonomije in korporativnega upravljanja. V svoji akademski karieri je objavil več kot 400 bibliografskih enot in obiskal 22 univerz po vsem svetu kot gostujoči profesor. Je član uredniškega odbora v šestih mednarodnih revijah in založniškem podjetju Intech v Londonu. Deluje tudi kot član strateškega sveta ministra za zunanje zadeve Repubike Slovenije. Ima dolgoletne izkušnje delovanja v akademskem svetu, v svetovanju in v podjetništву. Leta 2010 je ustanovil svetovalno podjetje Palemid, kjer je vodil 20 velikih projektov, kot sta npr. Program sodelovanja Interreg V-A Slovenija-Avstria (2014 - 2020) in izboljšanje zmogljivosti za srbsko zbornico izvršiteljev. Svetoval je tudi multinacionalki Andritz A.G. iz Avstrije, pa podjetju Talum d.d. in drugim. Sodeloval je tudi v številnih mednarodnih projektih v Italiji, Nemčiji, Združenem kraljestvu, ZDA, Španiji, Turčiji, Franciji, Romuniji, Hrvaški, Črni gori, Maleziji in na Kitajskem. Je tudi soustanovitelj Visoke šole za regionalni management AREMA v Sloveniji. V zadnjih 17 letih je bil tudi član nadzornega sveta KBM Infond DZU. Na svojih prejšnjih funkcijah je deloval kot član Team Europe Slovenia, član Akademske strokovne skupine pri Komisiji EU (DG za izobraževanje) za ocenjevanje projektov Socrates / Erasmus ter kot svetovalec ministra za ekonomske odnose in razvoj Slovenije glede strategije mednarodnih ekonomskeh odnosov.

Vito Bobek works as a professor for international management at the University of Applied Sciences FH Joanneum (Graz, Austria), Faculty of Social Sciences, University of Ljubljana, and Faculty of Economics and business, University of Maribor, and Faculty of Social Sciences, University of Ljubljana. He published over 400 units in his academic career and visited 22 universities worldwide as a visiting professor. He is a member of editorial boards of six international journals and an Open Access publisher Intech in London.

He has a long history in academia, consulting, and entrepreneurship. In 2010, he founded the consulting firm Palemid, where he has managed 20 significant projects such as Cooperation Program Interreg V-A (2014 Slovenia-Austria - 2020) and Capacity Building for the Serbian Chamber of Enforcement Agents. He has also participated in many international projects in Italy, Germany, Great Britain, the USA, Spain, Turkey, France, Romania, Croatia, Montenegro, Malaysia, and China. He is also a co-founder of the Academy of Regional Management in Slovenia.

Among his previous functions, he was a member of the Supervisory Board of KBM Infond Management Company Ltd, which belongs to the Nova KBM, Plc. Banking group, a member of the Team Europe Slovenia, member of the academic expert group in the Commission of the EU (DG Education) to evaluate Erasmus projects, and advisor to the Ministry of Economic Relations Development of Slovenia for the strategy of International Economic Relations. He also served as a member of the Strategic Council of the Minister of Foreign Affairs of the Republic of Slovenia.
