Reference nosilca / Lecturer's references:

Doc. dr. Tatiana Bajuk Senčar je znanstvena sodelavka na Inštitutu za slovensko narodopisje Znanstvenoraziskovalnega centra Slovenske akademije znanosti in umetnosti (ZRC SAZU). Na svoji raziskovalni poklicni poti je sodelovala na več kot 15 nacionalnih in mednarodnih raziskovalnih projektih (vodila jih je 4) ter objavila več kot 30 izvirnih znanstvenih člankov in znanstvenih poglavij ter napisala dve znanstveni monografiji. Čeprav so njeni raziskovalni interesi raznovrstni, se je kot antropologinja posvečala predvsem preučevanju vprašanj, povezanih s trajnostnim razvojem in manifestacijami globalizacije s pomočjo kvalitativnih, predvsem etnografskih metod. V zadnjih letih so njene raziskave osredotočene na migracije, mobilnost in multilokalnost v ruralnih in urbanih območjih v Sloveniji. Je članica uredniške odbora znanstvene revije *Traditiones* in gostujoča urednica tematskih števil v tujih znanstvenih revijah. V okviru aplikativnih projektov sodeluje tudi z različnimi lokalnimi institucijami in organizacijami.

Dr. Tatiana Bajuk Senčar is a Research Fellow at the Research Centre of the Slovenian Academy of Sciences and Arts (ZRC SAZU), Institute of Slovenian Ethnology. She received her Ph.D. in cultural anthropology from Rice University in Texas (USA) in 1998. During her career, she has collaborated in over 15 national and international research projects (leader in 4) and published over 30 scientific articles and chapters as well two scientific monographs. While her research interests have been diverse, as an anthropologist she is dedicated to the use of qualitative, ethnographic research methods to explore questions linked to sustainable development and globalization in a variety of manifestations. This has included a long-time research interest in mobility, migration, and multilocality - both in rural and urban areas in Slovenia. She is a member of the editorial board of journal *Traditiones* and has been a guest editor in foreign scientific journals. She also collaborates with institutions and local organizations in communities in the form of applied projects.
