(\*\*\*) Under point 7, the faculty may not charge for the following conclusions:

- decision on meeting the conditions for taking exams from the higher year;
- decision on the recognition of exams within NU;
- decision on the early completion of exams;
- decision on faster advancement;
- a decision on changing an optional subject;
- decision on parallel studies at other faculties or universities;
- decision on extending the deadline for the preparation of the final work;
- decision on raising the assessment;
- decision on granting the status of a student with special needs;



- decision on the recognition of non-formal education.
